- Duane went over the treasurer’s report from the email and provided exact numbers (listed above) for what was originally listed as an estimate. All banks accounts switched to Truist bank and \$2 left in Regions until that account can be closed. It has to be closed in person and he had covid so he was not able to do that as of when this meeting took place.
- The card reader charges a 1.9% fee per transaction however, this is less than paypal and credit cards. He was able to call Merchant’s bank and put the card reader on hold until the reunion when we will for sure be using it again.
- Motion to accept the treasurer’s report at 1810; motion carried by unanimous vote.

- **QUARTERMASTER REPORT:**
 - Ed Rodriguez reported the following:
 - Sales have increased form last month, continuing the upward trend over the last few months.
 - New zippered hoodies are on order and should arrive later this month.
 - The black strap hats are selling and the mag hats are almost sold out. May have to increase prices on hats due to inflation. 2018 reunion shirts are selling as well and it is noted that the new inventory is helping these move which is good because we do need to get rid of them.
 - He received a disabled veteran membership request but he was already in our database so there is no need to give him a new number. The check was destroyed.
 - He goes over the May 20th festivities for the Defuniak Springs Lake Day as per what was in the email. In addition, he mentions that we will sell our merchandise under a tent. We will prep everything the night prior and finish setting up by 9am the day of. It will close at about 2pm. It was noted that they usually have a parade around 3pm and there was some discussion if we should stay “open” for that but we will most likely not do that.
 - Numbers for sales are detailed- we owe \$116.34 in state taxes from March.
