Pat reported that only 44 members voted this past year on the proposed amendment to the By Laws to allow out-of-town members to serve on our Board of Directors. Forty (40) voted in favor of the amendment and four (4) voted against the amendment. The motion carried and our By Laws have been amended to reflect this change.

Discussion ensued about participation by our members in the business of the organization. Voting on line was suggested. Our Web Master is working on setting up on-line balloting for the membership to cast their ballot.

This year we have fourteen (14) Applicants for the Spectre Association Scholarship. This count includes two (2) sets of twins. Gunner Jack picked two (2) sealed envelopes: a Primary Recipient and a Secondary Recipient for the Association Scholarship.

The Spectre Association has received word from the State of Florida that we are formally being considered to become a Tax Exempt Military Support Organization. We are still waiting for the final approval to be received.

It was moved and seconded that these nominations be presented to the membership at large for election of Board Members. Motion carried.

Kim Coryat presented a Proposal to Increase our Dues. This was presented in the form of a proposed change to our By Laws. Discussion:

### What we are doing now:

Annual Dues: \$15.00 Lifetime Dues: \$150.00 -- \$100.00 if over the age of 55

### Recommendation:

- 1. Raise our Annual Dues to \$25.00
- 2. Raise our Lifetime rate to \$250.00 for members under the age of 55, \$200.00 for members ages 56 to 69, and \$150.00 for members ages 70 and up.
- 3. Members who are at least 30% disabled vets will pay the same annual dues but will pay  $\frac{1}{2}$  the lifetime rate when they submit qualified proof of their disability.

### Discussion:

Increase in operating costs (supplies, rent, postage, etc.), web hosting, and Internet site, on-line store fees. Seven (7) military organizations with a web presence were surveyed: Air Commando Association, AC-119 Association, Combat Control Association, Special Operations Association, AFA, NCOA, Vietnam Veterans of America.

We are way behind the power curve in what we charge for our annual dues, no organization surveyed is under \$20.00 a year. We will be a little ahead of the pack with smaller organizations that were surveyed if we adopt changes but in line with larger ones when it comes to lifetime dues. New and noteworthy is a break for Disabled Vets!

Norm Evans moved that we accept the proposal to the By Laws as it is written and that it be sent to the membership at large for a vote. The motion was seconded and motion passed.

Pat Carpenter proposed a change to Scholarship eligibility---Discussion Current By-Law Article for Scholarship Eligibility

### Article XIII

3. The association will sponsor a minimum of one (1) scholarship for higher education each year for dependent children of members in good standing. The selection will be from a blind draw of eligible dependent children who have been submitted prior to each yearly reunion. Eligibility shall remain in compliance with the IRS definition of dependency and the dependent shall be enrolled or accepted at an accredited University, College, Junior College or Trade School. The student must be enrolled for a minimum of three quarter time as defined by current Veterans Administration standards. As funds allow, the association may award more than one scholarship each year. Upon selection, the member and student must notify the association secretary of the school address. Moneys will be transmitted to the school no later than January 15 in the name of the student.

Proposed Amendment to the By-Laws for Scholarship Eligibility

### **Article XIII**

### **Proposed Change**

- First sentence to read The association will sponsor a minimum of one (1) scholarship for higher education each year for dependent children or dependent grandchildren of members in good standing, with lineage to the grandchild of a member provided on the scholarship application.
- Remaining definition remains unchanged.

### Rationale

- The average age of the membership.
- Members who have children of college age vs. those with grandchildren of college age.

After a great deal of discussion, the proposal died for lack of a motion.

### **MEMBERSHIP OPEN FORUM:**

It was noted that the AC-119 Association has many more members in their organization than we have, and more of their members are attending the reunion than we have. We have about 385 total persons representing all of the organizations pre-registered for this reunion.

**Dr. Steve Maxner, Ph.D.** and Director of The Vietnam Center at Texas Tech University in Lubbock, TX, shared with us what his program is doing to promote the study of the Vietnam War. They have raised over \$10 Million in memberships and donations plus have received \$2.3 Million from the federal government in grant monies. They have collected over 20 million pages of material about the War to include paper documents, microfilm, microfiche, photographs, slides, maps, audio, and video recordings, periodicals, books, oral history interviews, and more. They want to preserve the memories of the War, and they lead the world in online archival resources in their Virtual Vietnam Archive on their web site. All of their information is free to any one with Internet access. If anyone donates printed material to The Vietnam Center it does not sit on a shelf. It is uploaded onto their Web Site in a timely manner. They also have a Vietnam Oral History Project whereby they can preserve the voices of the past. Anyone who is interested in participating in any of the programs of The Vietnam Center can visit their website at <a href="http://vietnam.ttu.edu">http://vietnam.ttu.edu</a> or telephone them at 806-742-3742.

Bill Allen asked to reopen the discussion about the proposed Amendment concerning allowing dependent grandchildren to be eligible for our annual scholarship. Pat opened this item for further discussion after which Bill Allen moved that we accept this Amendment with the change of removing the word

DEPENDENT. The Motion was seconded, and the vote was taken. Eight (8) members voted IN FAVOR of sending the proposed Amendment to the membership at large for a vote and twenty-six (26) members voted against sending the proposed Amendment to the membership at large for a vote to change our By Laws.

People were upset about the situation at the Friday night mixer and a lengthy discussion ensued. Many of our Membership believe that the hotel owes the organization a BIG refund because of the food that was *not* supplied. Further, the Hotel also opened doors at least an hour before appointed time.

Chuck Kaczmarczyk talked about the high prices that were charged for this year's reunion and the fact that he has heard from quite a number of our members complaining about this. A significant portion of our membership has retired and moved away from the Fort Walton area and people feel that the By Laws should be changed to allow the Reunion to be held in different parts of the country more frequently than once every four (4) years. Pat said they definitely had a problem with rooms this year and finding a place large enough to serve 400+ people for the meals. It was noted that prices are steadily going up in Ft. Walton.

The 16<sup>th</sup> SOS is moving to New Mexico. It was asked, "How will this affect us?" Pat said that he is searching for new blood to work on the Board of Directors and on different Organization committees.

Their being no further business and no further comments to be made, it was moved and seconded to adjourn at 1020 hours. Motion carried unanimously.
