#### **OLD BUSINESS:**

Apparently someone had requested the hospitality room for those days even though we don't need them. Bill asked what the cost is for each night and it's \$300 for \$600 total. Apparently Hutch had planned something for Sunday and there was some discussion for this. Duane noticed that both the banquet room and hospitality room were booked. Bill had a vote cast to completely cancel the hospitality room for those nights and to just keep the banquet room; motion passed with unanimous vote at 1813 central. However it's noted that we need to make clear that we will only pay for the room, not food. Lastly the information for the reunion needs to be updated soon; people are already asking for it.

• Bill said he talked with the Air Force museum (in Dayton OH) about opening the gunship there
