### **CALL TO ORDER:**

Fred took roll and thanked the members for their attendance. He also made aware the folks taking over for treasury (Duane, with Ed R as secondary) and secretary (Amanda).

It was discussed that the operating fund could be used for any other expenses such as the reunion. Also the bond responsibility will have to "get a handle on." Ed also mentioned the corporation report was \$75. A motion was made to approve and accept the treasurer's report. Motion carried by unanimous vote. Ed R continued on with the quartermaster report (below).

### • QUARTERMASTER REPORT:

- o Ed R reported:
- He asked if everyone saw the email with the report and everyone did say they saw it. Immediately there was a motion to approve accept the report. The motion was accepted.
- Ed R went over sales as per the report. He said it did pretty well this year in comparison to the past. He also noted that what was color coded green is what our actual inventory sales are and that state taxes are due.
- In 2017 we had a tax refund for \$49.19 that they were unaware of.
- Paypal was forgetting to tax certain purchases. New calculations will include this. Also, memberships and donations are not taxed but paypal does charge a fee.
- He goes through what was sent in the email.
- Unsure if 2016 tax information was submitted and noted that he has to follow up with accountant.
- Long sleeve shirts are selling well. New polo shirts are ordered but haven't arrived yet. New keyholder tags and patches are selling well. Fred asked why the merchandise is selling more and Ed R said it's probably because of the new designs and new stuff available.
- USPS raised rates. Now \$10 to \$20 for shipments under \$50.
- Confusion noted for sales tax in 2016 and 2017. State says we owe them (even though we had a refund in 2017). Inventory is taxed. Shipments are not included- state doesn't require taxes.

**OLD BUSINESS:** none discussed; went straight to reunion planning.

### **DISCUSSION:**

- Reunion Planning
  - o Bill sent out schedule for 2023 reunion. Suggestion for Thursday night registration to set up tables in the hallway in order to get people into the store.
  - Fred asked about the guest speaker. Bill stated Col Connors is a possible guest speaker but unsure of availability as of yet. Col Black is a possibility if Col Connors isn't available.
  - Ed R brought up the menu. Wants to base attendance on last years attendance. Fred states
    we have until the last month to really figure this out. Apparently the chef (at the hotel)
    was pretty bad back in December- they got a new chef.
