### BUSINESS

- o Bill:

- Plenty of discussion about Kathy's book. Noted that Duane and Ed will partner with Kathy for offsite reunion planning since both of them have access to the money and inventory.
- Vote to commit to the hotel at 1824, accepted.
- o Scholarship checks are already gone.
- o Noted Vito's vacancy in the board and was suggested I (Amanda) take his spot.
- o For the Gunner Jack Award, at present whatever the interest earned is what the recipient receives. Discussion about using either the interest earned or a flat rate of \$500; noted that in some years the interest is not very much so the recipient may not get very much and in other years it may be alot. It was reiterated that the intent Gunner Jack had was to only use the interest. Duane was the recipient this year.
- Found a membership log from the 1990s and has been parsing through it to correctly reflect who is still alive. As it stands, it inaccurately shows we have more members due to deaths not being reflected.
- O Duane:
- The income/ loss document was discussed. Noted that scholarships shouldn't be on there and once that was taken off, the difference was around \$2,000. \$20,445.79 made in total from the reunion from various sales and donations. \$22,649 was the total cost for taxes, fees, merch, hotel, food etc. The difference this year, while still at a loss, is much better than in years past.
